Eligibility Criteria

1. Candidate applying against the post vacant at District Employment Exchange, Tuensang and Govt. Industrial Training Institute, Kohima shall be indigenous inhabitants of the concerned district.
2. Minimum age of a Candidate should not be less than 18 years as on 01/01/2023 and not more than 35 years of age as on 01/01/2023. The relaxation of upper age limit will be governed by the existing policy of State Government, including those serving employees under State Government.
3. Serving Govt. Employees are required to submit "No objection Certificate" duly signed by the Head of Department with name and Official Seal, indicating the date of initial appointment of the candidate.
4. Application form may be obtained from the Directorate of Employment, Skill Development & Entrepreneurship, Kohima, District Employment Exchange, Tuensang and Govt. Women Industrial Training, Seithekema during Office hours from 10:30 A.M to 3:00 P.M from 05/01/2023 onwards.. Last date for accepting application shall be 10/01/2023 till 3:00 P.M.
5. Incomplete application shall be summarily rejected.
6. Updated Employment Registration Card (Photocopy) should be produced.
7. The minimum qualification shall be Class VIII (eight) passed.
8. Mode of selection shall be through Viva-voce. Shortlisted candidates shall be intimated through phone for Viva-Voce on 16/01/2023. The Result shall be declared on 17/01/2023

 - c. Schedule Tribe Certificate.


