Item No.2	- Graduate in any discipline and Diploma in Steno. Age limit- Minimum 21 years Maximum 35 year as on 01-01-2017.
Item No.3	- 12 <sup>th</sup> Class passed Age limit- Minimum 21 years Maximum 35 year as on 01-01-2017.
Item No.4	- The Candidate should be conversant with the Naga Customary Laws and practices Age limit- Minimum 25 years as on 1-1-2017 and no upper age limit within superannuation.
Item No.5	- The Candidate should posses Driving License issued by the Competent authority Age limit- Minimum 21 years Maximum 35 year as on 1-1-2017.
Item No.6, 7 & 8	- The Candidate should have read upto Class VIII. Age limit- Minimum 18 years Maximum 35 year as on 01-01-2017.
