Sealed offers under TWO BID SYSTEM are invited by GOVT. OF NAGALAND from non-scheduled Operators for WET lease of ONE number twin Engine Medium Duty Transport (Passenger 7-15 Seater) helicopter for an initial period of two years in the prescribed bid form and the proforma attached to this bid package. Wet lease of ONE number twin engine medium duty transport passenger helicopter for an initial period of two years. The helicopter is to be utilized mainly for passenger services, VIP transportation, carrying of sick or the patients and air-maintenance task etc. in Nagaland or any other location in India. Monthly utilization will be 50 hours which can be further extended subject to the approval of the MHA, Govt. of India.

3. Delivery period :- Bidder to mobilize the helicopter at Dimapur within 15 days from the date of letter of intent.
