CORRIGENDUM

No. NSeGS/eDistrict-5/2013 :: Pursuant to the Pre-Bid Meeting for Selection of Nagaland eDistrict System Integrator held on 8th July 2014 at the Directorate of Information Technology & Communication, accepted changes to the RFP Clauses are as follows:-

1. **Bid Schedule, RFP Volume I, Para 2:** Revised with new dates for the bidding process. Bidders will also have to make a Technical Presentation on their solutions as scheduled.
2. **Key Requirements of the Bid, RFP Volume I, Para 5.4:** Revised from Manual Process to Online Process. Online Payment for Tender Document Fees has been included. Subsequently the Price Bid Templates have also been modified to suit online bidding.
3. **E-District Functional Modules, RFP Volume II, Para 4.3.2.2:** Scope of Work of SI pertaining to Enterprise Monitoring System (EMS), e-Forms and SSDG Connectors has been modified as per bidders recommendation.
4. **Network Connectivity, RFP Volume II, Para 4.3.5:** Changes as recommended by bidders under Network connectivity has been incorporated.
5. **Bill of Material (Software), RFP Volume II, Para. 6.7.1:** The Number of Licenses as indicated in the Software Bill of Material has been modified as per Bidders recommendations to enable them to submit their solutions based on Number of Users.
6. **Technical Specifications, RFP Volume II, Para 6.7.4 :** The configuration of Desktops, Laptops, Blade Servers, Access Switch-L3, UPS, Router etc has been modified as per Bidders recommendation to include new available technology. The use of Open Source Databases have also been included in relevant clauses pertaining to Database, eDistrict Manpower Qualifications etc.
7. **Site Preparation Requirements, Para 6.4, RFP Volume II (Annexures):** Supply of furnitures has been removed and scope of electrical wiring has been revised as per bidders recommendation.

In light of the above modifications, the revised RFP Volumes I, II and III has been prepared and Bidders are requested to refer to the revised RFP for bid submission. **Any bids that are submitted in reference to earlier RFP shall be summarily rejected.** Bidders may download the revised RFP from any of the following websites :-



The bidding process will be carried out through e-Tendering at www.nagalandtenders.gov.in. Uploading of documents in the specified website and submission of the same along with CD (Read only) (for Pre-Qualification and Technical Proposals only) is mandatory and the bid will stand rejected if only offline bid documents are submitted.




