**NOTIFICATION**

**Dated Kohima, the 26<sup>th</sup> October, 2017**

**NO.PAR-B/5/2007 NPSC** : In exercise of the powers conferred by Article 318 and proviso to Article 320(3) of the Constitution of India, the Governor of Nagaland is pleased to make the following rules further to amend the Nagaland Public Service Commission (Chairman, Members & Staff) Regulations, 2008, namely:-

1. (1) These rules may be called the ***Nagaland Public Service Commission (Chairman, Members & Staff) (7<sup>th</sup> Amendment) Regulations, 2017.***  
(2) They shall come into force with immediate effect.

2. **Amendment of Introductory paragraph**

The introductory paragraph of the Nagaland Public Service Commission (Chairman, Members & Staff) Regulations, 2008 shall be substituted as follows:

***"In exercise of the powers conferred by Article 318 and proviso to Article 320(3) of the Constitution of India, the Governor of Nagaland is pleased to make the following regulations to regulate the composition and conditions of service of the Chairman, Members and Staff of the Nagaland Public Service Commission and recruitment to civil services and posts"***

3.1 **Amendment of Regulation 3 sub-clause (3)**

The entries under Regulation 3 sub-clause (3), the word "Commissioner & Secretary" shall be substituted with "***Secretary***"

3.2 **Amendment of Regulation 3 sub-clause (4)**

The entries under Regulation 3 sub-clause (4), the word "graduate" shall be substituted with "***post graduate***"

3.3 **Amendment of Regulation 3 sub-clause (5)**

The entries under Regulation 3 sub-clause (4) shall be substituted with the following:

***"The Search Committee for making recommendations for selection of candidates as Members or Chairman of NPSC shall consist of the following:***

### 3.4 Amendment of Regulation 3 sub-clause (6)

The entries under Regulation 3 sub-clause (6), the word "true" shall be added before the word "faith".

### 4. Amendment of Regulation 15 (1)

The entries under Regulation 15(1) sub-clause (i) shall be substituted with the following:

**"When an appointment is to be made to non-gazetted post except the posts of Secretariat Assistant belonging to the Nagaland Secretariat Service."**
