INVITATION FOR BIDS (IFB)
NATIONAL COMPETITIVE BIDDING

Notice for Inviting Bids for construction of new buildings and renovation of existing building at the State Environment and Forestry Training Institute (SEFTI), Dimapur (Nagaland).

- The Department of Forests, Ecology, Environment and Wildlife, Government of Nagaland is implementing a Japan International Co-operation Agency (JICA) assisted project titled "Capacity Development for Forest Management and Training of Personnel" (IDP-199) and intends a part of the fund to cover eligible payments under contracts for construction of works as detailed below. Bidding is open to all eligible bidders from the country. Bidders/firms should be registered with Government of Nagaland or other State Government/ Government of India or State/Central Government undertaking. **Bidders are advised to note the minimum qualification criteria specified in clause 4 of the Instructions to Bidders to qualify for the award of the contract.**
- The Director, SEFTI, Dimapur, and Member Secretary SPMU Nagaland invites bids for the construction of the following new buildings and renovation of the following existing buildings :



The Bidders may submit bid for any or all of the above mentioned works.

Bidding documents may be purchased from the office of the Director, SEFTI, Dimapur, Nagaland from **10:00 am of 16/09/2014 to 12:00 Noon of 09/10/2014**, for a non-refundable fee , in the form of Cash or Demand Draft on any Scheduled bank payable at Dimapur in favor of the Director SEFTI on payment of Rs 3000/- (Three thousand) only. The Director will not be held responsible for the postal delay if any, in the delivery of the documents or non-receipt of the same if the request is made by dispatch of Bidding Documents by post. An additional amount of Rs. 300/ (Rupees three hundred only) will have to be paid in Demand Draft or in cash along with the application for meeting postal expanses.
4. Bids must be accompanied by the security of the amount specified for the work in the table above, drawn in favour of **The Director, SEFTI, Dimapur, Nagaland**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for 45 days beyond the validity of the bid.
5. Bids should be valid for **90** days after the deadline date specified for submission.
6. Bids in sealed cover must be submitted to **"The Director, SEFTI, Dimapur and Member Secretary, SPMU, Nagaland"** as the case may be on or before **14:00** hours on **09/10/2014** and will be opened on the same day at **14:30** hours, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
7. Other details can be seen in the bidding documents.
8. Mere submission of bids will not confer applicant's any right for receiving or carrying out the tendered job. Forests Department, Nagaland reserves the right to accept/reject one or all bids or stop the process of approval at any stage, at its sole discretion without assigning any reasons and shall bear no liability whatsoever consequent upon such a decision.
