NOTICE INVITING TENDER

Sealed offers under 'TWO BID SYSTEM' Priced & Un-Priced Bids, are hereby invited by GOVERNMENT OF NAGALAND from non-scheduled operators for WET Lease of 2(Two) Numbers of Twin Engine Medium Transport Passenger 13+2 Type Helicopters, pursuant to Ministry of Home Affairs NE-Division, North Block, Government of India, vide F. NO.18/06/2012-NE(Pt) Dated, 10.10.2018, for initial period of 2(Two) years in the prescribed Bid Form and Proforma attached to this Bid package. Details of the Tender are given as below:

1. Tender NO : NST/HELI/482/2018-19/782 Dated : 30.10.2018

2. Description :

Wet lease for 2(Two) numbers of Twin Engine Medium Duty Transport Passenger Helicopter for an initial period of 2(Two) years. The Helicopter is to be utilized mainly for passenger services, VIP& VVIP transportation, carrying of Sick or Patients, Government Emergency Duties, air-maintenance task etc. in Nagaland or any other location in India. Approximate Flying Hours will be 1200 Hrs. per annum, i.e, 100 Hrs. per month (600 Hrs. each per Helicopter per annum) which can further be extended subject to approval of Ministry of Home Affairs (MHA) Government of India.

3. Delivery Period : Bidder to mobilize the Helicopter at Dimapur within 15(Fifteen) days from the date of Letter of Intent (LoI).

4. Tender Closing Date and Time for submission of Bids : 1200 Hrs.(IST) before 16.11.2018

5. Tender Opening Date and Time :

1300 Hrs.(IST) on 16.11.2018 – for Un-Priced Bid

1200 Hrs.(IST) on 17.11.2018 – for Priced Bid

Bidder(s) whose Un-Priced Bids are found incomplete, not supported by Bid Bond and/or deficient of any technical parameters, their Priced Bids shall not be opened and shall be returned to the Bidder in Sealed condition as submitted by them.

6. Bid Bond (Bank Guarantee) : 15 (Fifteen) Lakhs, each.

7. Tender Bid Validity up to : 6 (Six) months from the Tender Opening Date, i.e, up to 16.05.2019.

8. Bid Bond Validity up to : 8 (Eight) months from the Tender Opening Date, i.e, up to 16.07.2019.

9. Performance Bank Guarantee :

i) Amount : 10% of the total Contract value for the Helicopter offered.

ii) Validity : 2 (Two) months beyond the initial 2(Two) years period of the Contract and extendable thereafter.

10. Priced Bids shall be evaluated with reference to the average passenger carrying capacity of the Helicopter offered for each sector (*Enclosed and marked as ANNEXURE-'A' in the Tender Documents*).
