OFFICE MEMORANDUM

Sub: Restructuring of the Departments of Information Technology Communication, Technical Education and Science & Technology.

1. In supersession of this Department Office Memorandum of even number dated 19th August, 2004 and 24th September, 2004, and in exercise of the powers conferred by Part III, Rule 58 (D) (3)(iv) of the Rules of Executive Business of Nagaland Government, the Governor of Nagaland is pleased to re-structure the Departments dealing with the subjects of Information Technology, Communication, Technical education and Science & Technology as indicated below.

- (i) The Department of Communication presently under Transport Department shall be merged with the Department of Information Technology.
- (ii) The subject matters of Technical Education alongwith the SPIU attached to it shall be merged back with the Department of Higher Education as it was before 01-10-2004 and be named as **Department of Higher and Technical Education.**
- (iii) The Department of Science and Technology shall be merged with the Department of Information Technology. The Department of Information Technology & Technical Education shall be renamed as the **Department of Information Communication & Technology, and Science & Technology (ICT&ST).**

2. The Governor of Nagaland is also pleased to order that the officers and staff dealing with the concerned subject matters in the Secretariat as well as the Directorates shall stand transferred along with the concerned files accordingly.

3. The inter-se-seniority of officers and ministerial staff in the concerned Department will be determined with reference to the date(s) of regular promotion of the respective officers and staff to their present status in their parent Departments.

4. This has the approval of the Cabinet vide O.M. No. CAB-2/2008 dated 10/10/008.

5. This order will take effect from 1st December, 2008.
