**No.RCBT/5/87 (Pt-III):** In partial modification of Para 1 of this Department's Notification No.RCBT/5/87(Pt-II) dated 14<sup>th</sup> April 2011, the Governor of Nagaland is pleased to include TIKHIR Tribe, which was recognized as a separate Tribe vide Notification No.HOME/SCST-30/TIKHIR/2022 dated 20<sup>th</sup> January 2022 as an educationally and economically backward tribe, and hereby directs that 25% of all categories, both gazetted and non-gazetted posts, under the Government of Nagaland shall be reserved for the persons belonging to the following 7(seven) Tribes of 6(six) districts of Mon, Tuensang, Kiphire, Longleng, Noklak and Shamator, with immediate effect:-

3. Sangtam
4. Yimkhiung
5. Chang
6. Khiamniungan
7. Tikhir
