NO.EDS(A)-5/2002 ::: On the recommendation of the State Level Education Committee, the Governor of Nagaland is pleased to notify herewith the policy on recruitment of teachers under the Department of School Education.

The minimum educational qualification for the recruitment of teachers in Elementary, Secondary and Higher Secondary Schools shall be:

1. ELEMENTARY SCHOOLS:

l.	Pre-Primary (Classes A & B)	-	10+2/Pre-U with PSTE or Diploma in Early Childhood Care Education (ECCE)
. .	Primary (Classes 1 to 4) Upper Primary (Classes V to VIII)	- 10+2/Pre-U with PSTE - Graduate with B.Ed.	
	ONDARY SCHOOLS: ses IX & X	-	Graduate with B.Ed.

In every recruiting year i.e. January to December, 30% of the total vacancies shall be fill up through Departmental selection from amongst the serving Elementary Teachers having the requisite educational qualification of Graduate with B.Ed and having 7 (seven) years of regular service as Upper-Primary teacher. This selection shall be made through the Departmental Promotion Committee and shall be for the particular subject/discipline in which vacancy arises.

3. HIGHER SECONDARY SCHOOLS:

Classes XI & XII

Post Graduate Degree having at least 50% in the concerned subject, with B.Ed.

In every recruiting year, 30% of the total vacancies shall be filled up through Departmental Selection from amongst the serving Secondary Teachers having Post-Graduate Degree with 50% aggregate mark in the concerned subject with B.Ed. and having 7(seven) years regular service which is relaxable by 5% for candidates of ST/SC.

This shall come into force with immediate effect.
